
R.M. of Wallace No. 243 Minutes Regular Meeting Friday January 10th, 2020

- Councillor's Supervision Mileage maximum of 12,000km
- Council members' maximum of 30 days for Supervision

Wonitowy: That the Council of the R.M. of Wallace No. 243 set the remuneration for the R.M. of Wallace No. 243 Election Officials as follows:


Returning Officer - \$350.00/day and mileage at \$0.55/km, Deputy Returning Officers - \$300.00/day and mileage at \$0.55/km,
